JUAN DE FRÍAS SALAZAR DEPARTS TO INSPECT THE FORCES OF DON JUAN DE OÑATE¹

Sir:

In the galleons I received a letter from the president of the Council of the Indies, Licentiate Laguna, in which your majesty notified me that Don Juan de Oñate was to make the expedition to New Mexico, provided he had ready, as was presumed, his army and the necessary provisions. If he did not, I was to notify your majesty so that you might provide what seemed most suitable to your royal service. Because of insufficient time to dispatch a cedula by that mail, it was to be sent at the first opportunity. I at once informed Don Juan of your majesty's will, warning him that if he were lacking in anything, he would not be allowed to make the expedition. I urged him to be frank with me, since I presumed that, after such a long delay, he would not have on hand the articles set forth in the capitulations, and I urged him not to delay any longer, without cause, the revelation of the true situation and thus cause greater harm and expense to himself and his relatives. He replied with much assurance and confidence in his ability to make the expedition at once, and quickly. He spoke with such extreme earnestness that I found myself obliged to send a person there to conduct the review, inspection, and inventory, even though he claimed that he was under no obligation to submit to one for a second time.

As the case demanded uprightness and integrity, with full consideration of the interests of your majesty and Don Juan, I chose Juan de Frías Salazar, native of the mountains of Burgos, resident and mine operator at Pachuca, a man who will give

full satisfaction in this or any other matter. Being both rich and well along in years, he possesses the intelligence and qualifications which the case requires. He was a soldier in Flanders for some years, and from the reports that I have, he served with great credit. Here he is considered a very reliable and dependable man, free from personal considerations or ambitions. I believe that he will carry out this inspection properly, and that this will determine whether or not Don Juan de Oñate should proceed with the expedition. So I had him get ready at the time when the ship arrived with the registers, and the cedula was there.

I dispatched the inspector at once, and he set out. I am hourly expecting word of his arrival, and, shortly thereafter, a report of what he found. I shall forward it to your majesty at the first opportunity, since it could not be done now, nor could much be done in such a short time, since Don Juan and his men are about two hundred leagues away.

The expedition is short of friars, and of those who went it seemed desirable to send back some who for special reasons were not suited for it. Among them there was one to whom the Holy Office of the Inquisition had entrusted a certain commission, and they did not want to name anyone in his place for the time being. Should the expedition proceed, I believe that they will permit the return of these friars. And since the rainy season is now over and Don Juan so depleted, it is necessary that everything be got in readiness, at the same time that other friars are getting ready to start out, which they will do one of these days. In the second report I shall be able to inform your majesty of everything that is being done in this matter, and the reasons that impelled me.

INSPECTION MADE BY JUAN DE FRÍAS SALAZAR OF THE EXPEDITION¹

In the city of Mexico, May 30, 1602, Don Gaspar de Zúñiga y Acevedo, Count of Monterrey, lord of the house and estate of Viedma and Ulloa, viceroy and lieutenant of the king our lord, governor and captain general of New Spain, and president of its audiencia and royal chancellery . . . stated that, in order to send his majesty and the royal Council of the Indies a copy of the proceedings of the inspection of the expedition to New Mexico made by Juan de Frías Salazar, it was necessary to draw up a certified copy in the usual manner and he ordered that this be done by one of the royal notaries. Count of Monterrey.

This is a copy, accurately and faithfully drawn, of a royal commission signed by his excellency, the Count of Monterrey, his majesty's viceroy, governor, and inspector general of this New Spain, countersigned by Martín López de Gauna, secretary of government, the tenor of which is as follows:

Don Gaspar de Zúñiga y Acevedo, Count of Monterrey, . . . observes that after Don Luis de Velasco, viceroy, made a contract with Don Juan de Oñate to undertake the expedition for the reduction and pacification of the provinces of New Mexico and to bring its natives to the knowledge of God our Lord and the way of salvation, certain capitulations were drawn up, which were later changed by him. After these modifications had been approved on behalf of Don Juan de Oñate, they were recorded, together with the changes, as is set forth more in detail in the capitulations themselves. And since one of the conditions was that an inspection and inventory should be made by someone appointed by the viceroy of the people, cattle, provisions, arms, munitions, and other things that Don Juan was required to

bring on the expedition, I ordered Don Lope de Ulloa y Lemos, captain of my guard, to proceed there for this purpose, as is well known. When he was about to conduct this inspection, I received instructions from his majesty to order Don Juan de Oñate to halt the expedition, which he did, and Don Lope, after holding some reviews and investigations, came back.

Inasmuch as Don Juan is now, in obedience to my instructions, detained at the limits of these provinces near Santa Bárbara and its confines, where one can well imagine that he has had great expenditures because of this delay, this and other considerations impelled me to advise his majesty of what had been done in this matter in fulfillment of the royal cedula. In reply to this and in view of the fact that his majesty instructs me, by cedula of April 2 of this year, if I should learn that Don Juan de Oñate has in readiness the people and other things necessary for the expedition, to order him to carry it out, and, in case he cannot carry it out, to make this fact known as soon as possible in order that the most appropriate measures may be taken in Spain in this matter, I accordingly inquired into the preparations that Don Juan had made in provisions, people, and other equipment, and whether he was prepared and ready to undertake the entrada; he replied to me by letter that he was quite ready, though poor and short of equipment, but that he would commence the entrada just as soon as I should give him permission to do so. As I am bound to grant him this favor and as he has to show, to my satisfaction, that he has fulfilled everything in the capitulations that he had agreed to, and since it is so long since his force had been inspected—with such manifest danger of its people, provisions, and other essentials breaking up-I ordered a new review and inspection of the people, cattle, carts, and other things, and an examination and inventory of the provisions, arms, munitions, and other equipment, articles for trading, and many other things, which he agreed to take on the expedition, all of which were to be examined by a person of authority, prestige, training, and experience.

Knowing that you, Juan de Frías Salazar, possess these and other desirable qualities for the fulfillment of this commission, by these presents I order and commission you, in the name of his majesty, to make this review, inspection, and inventory,

which you are to carry out before the royal notary, Jaime Fernández, whom I have appointed for this purpose. You are to avail yourself of the aid that will be rendered you by Captain Luis Guerrero, whom I have appointed for this specific purpose, and of an alguacil and an interpreter, whom you will take along. For the discharge of these duties I grant you such power and authority as may be necessary either to discharge the whole commission or a portion of it, as well as to summon and notify Don Juan de Oñate and all the other leading officials of the expedition, captains as well as soldiers, that they shall obey you and carry out your orders and commands, without excuse or reservation. You are likewise empowered to proceed against anyone, without exception, who should prove disobedient or rebellious.

It is also my will that you shall hear all cases and offenses of which any of the said persons may be accused, for it is my purpose that while you are engaged in this commission at the camp of Don Juan de Oñate or in any other place where you may be, you shall be my commissary general, not only in what concerns this review, inspection, and inventory, but also in disciplining and punishing the soldiers. In both cases you are to be their judge and superior, as my lieutenant captain general, in order that thereby his majesty's orders and whatever befits his service may be more effectively carried out. In this capacity you shall proceed with the punishment of the guilty parties, according to the practices of war, in camp or on the field, as you deem most appropriate.

I command Don Juan de Oñate, and all the other persons in his force and under the jurisdiction of this government, not to act contrary to what is herein prescribed, or to any portion of it, under the penalties that you may impose on them. On the contrary, they shall render you the assistance and support which you may demand, without any excuse or delay.

During the time that you are engaged in the aforesaid commission, you shall receive a salary of three hundred pesos per month. In like manner, Captain Luis Guerrero shall receive four pesos per day; Jaime Fernández, three pesos per day; the alguacil, twenty reals; and the interpreter, two pesos per day. All of this the officials of the public treasury in this city shall

disburse from the public funds in their care, charging it to expenses of war. Dated in Mexico on September 18, 1597. Count of Monterrey. By order of the viceroy, Martín López de Gauna.

Then, after the signature of the viceroy, the following was added in the hand and with the rubric of his lordship:

Captain Luis Guerrero is to assist you in whatever you may order him to do, and to observe your instructions, without overstepping them.

This copy of the royal commission I, Jaime Fernández, notary of the king our lord, made by his command from the original, which remains in the possession of the commissary general. By his order and in testimony thereof, I affix my signature and seal. In testimony of the truth, JAIME FERNÁNDEZ, royal notary.

By order of Juan de Frías Salazar, his majesty's inspector, commissary general, and lieutenant captain general of the army of New Mexico, all the soldiers and fighting men of the expedition in this city, district, or territory must leave here within three days and proceed to the said camp, going directly to Fresnillo, which is on the way, eight leagues from this city of Zacatecas. The commissary general will be waiting for them there at the end of this time to give them the instructions that they must follow in order to avoid excesses and disorders. These instructions they must observe, under penalty of death, even though they may have come under orders of their governor, for this policy befits the service of his majesty and the quick and happy dispatch of the expedition, which is what is sought. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

PROCLAMATION

I, royal notary and secretary, . . . certify that I ordered the publication of this proclamation in the city of Zacatecas, New Galicia, which was done publicly by the town crier in the plaza of the said city, in Tacuba street, in the presence of many people. I so certify. Jaime Fernández, royal notary.

NOTIFICATION—FIRST SUMMONS

In the villa of San Bartolomé, at Santa Bárbara, on November 16, 1597, Juan de Frías Salazar, . . . ordered me, secretary of

his commission, to notify Don Juan de Oñate . . . in his name that he has come by authority of his majesty and by order of the viceroy of New Spain, and that he is now in this camp to review his soldiers and to make a thorough inspection and inventory of the arms, munitions, and other equipment, which, according to his contract, he is under obligation to take on the expedition. And since, for the service of his majesty and the quick and proper dispatch of the expedition, it is necessary that the force set out forthwith on a direct route with all its equipment and provisions, in order that it may be inspected and the inventory made at the most suitable place, the governor shall give the proper order to begin the march. Further, at the close of this decree and after it is announced he shall furnish a statement signed by himself, the maese de campo, sargento mayor, and all the captains and officials in his army, giving the name of each one and indicating those who have soldiers enrolled under their banners or flags and those who have no companies or soldiers.

Moreover, all soldiers, captains, or officials who henceforth may come to this camp to join the expedition, whether they be people already enlisted, but absent, or those newly recruited, must first of all present themselves in person before the said lieutenant captain general, for this befits the service of his majesty. The governor shall be summoned to comply with all the aforesaid, without any evasion or delay. Thus he ordered and signed, Juan de Frías Salazar. By his command, Jaime Fernández, royal notary.

Notification

In the camp of San Bartolomé, Santa Bárbara, with the expedition to New Mexico, on November 17, 1597, I, royal notary of the inspection, notified Don Juan de Oñate . . . and read to him the preceding order from the commissary, inspector, and lieutenant captain general. After listening to it, the governor said that he knew that the inspector had arrived to hold the review and to dispatch the expedition, and that he was very well satisfied and ready. So, even though he had stored in warehouses all of the provisions and other necessary supplies that he was bound to provide, as is known to the inspector, he will proceed

at once to load his carts with all of the provisions and equipment, without the loss of a moment's time, in order that the inspector's orders and what he himself has desired so much may be carried out. He will submit to the review at whatever place or locality he is instructed, and he will order the horses, mules, and oxen rounded up for this purpose. As to the list of the captains and soldiers, it will be compiled and delivered as requested. For this purpose Governor Don Juan de Oñate in the presence of me, the notary, called before him the maese de campo and the sargento mayor and ordered them to make a complete and accurate list at once, and to give it to me, the secretary. All other details of the order will be fulfilled as required. This was his reply, which he signed, and he asked to be furnished with an affidavit of it all. Don Juan de Oñate. Jaime Fernández, royal notary.

DECREE

Juan de Frías Salazar . . . decreed that inasmuch as the viceroy of New Spain had sent him to this camp with certain commissions, including one to prevent the residents of these provinces, whether Spaniards or Indians, from being molested, vexed, or harmed in any way by the people and soldiers of the expedition, and that if any injury had been done them they must be compensated, which he is determined to fulfill and enforce, and in order that this may be made public and brought to the attention of the settlers and natives, Captain Juan de Gordejuela, alcalde mayor of this province, is to be notified in order that he, as the person in charge of its administration and who knows the people, may make known the aforesaid information so that if anyone should come to lodge complaints, he will be ready to hear him and to render justice. He so ordered and signed. Juan de Frías Salazar. I so certify, Jaime Fernán-DEZ, royal notary.

NOTIFICATION

In San Bartolomé, Santa Bárbara, on November 21, 1597, I, royal notary and secretary of the investigating commission, made known the aforesaid order to Captain Juan de Gordejuela Ybarguen, alcalde mayor of this province, and read it to him

in person, in the presence of other residents. Accordingly, they are informed of it, as is also the father guardian of the convent of this pueblo of La Oyan. I so certify. Jaime Fernández, royal notary.

PROCLAMATION

Juan de Frías Salazar . . . orders that no soldier or any other person belonging to the army shall be so bold as to cause offense to anyone living in this valley, whether they be Spaniards or Indians, take anything from them against their will or without compensation, or slaughter any cattle which may belong to others, under penalty of paying four fold for it the first time, of suffering six stripes, and of being punished much more severely the second time. In order that all may be aware of this decree and not plead ignorance, he ordered that it be published in the plaza de armas of the army, and in two other places where people usually gather. This shall be done by proclamation of the town crier and by trumpet. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

PUBLICATION

In this valley of San Bartolomé, Santa Bárbara, at the camp of the army bound for the conquest of New Mexico, on November 21, 1597, I, royal notary, . . . ordered the above proclamation to be published orally and by bugle by the town crier in the plaza de armas of the said camp, and at two places in the quarters of the married people, as a result of which it was heard throughout the camp, as most of the soldiers were present. I so certify. Jaime Fernández, royal notary.

DECREE-SECOND SUMMONS

In the valley of San Bartolomé, Santa Bárbara, on November 23, 1597, Juan de Frías Salazar . . . said that he was ordering, and did order, Governor Don Juan de Oñate to be notified for a second time to get in readiness the people and everything else needed, in conformity with the terms of his contract, in order that the review, inspection, and inventory might be made in accordance with the orders of his lordship, the viceroy, as delay might result in inconveniences. The inspector is ready to hold the review at the place which he considers most suitable

for the service of his majesty. He so ordered and signed. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

NOTIFICATION

With the army of New Mexico in the valley of San Bartolomé, Santa Bárbara, on November 23, 1597, I, royal notary, . . . read the preceding decree to Don Juan de Oñate, governor and captain general of the expedition. Having heard it, he made the same reply as to the first decree, which was of the same tenor as this one, namely that, as the commissary general knows, he has everything in readiness that he was obliged to have by his contract and was ready for the review at this place, in accordance with his capitulations. For this purpose he had ordered the carts unloaded and the goods stored. Now, since the commissary general orders and commands that this review be held elsewhere, it will become necessary to load the carts and get them ready to travel. This loading could be done at the same time that the inspection is made, but inasmuch as the commissary general's orders had been issued, he replied as before that he was exercising all diligence and speed possible, as was well known and evident to all. This he answered and signed. Don Juan de Oñate. I so certify. Jaime Fernández, royal notary.

PROCLAMATION

Juan de Frías Salazar . . . orders that no one at the said camp, whether he be an official, soldier, or any other person, regardless of his quality or position, even if he does not belong to the force, dare lend Governor Don Juan de Oñate, under any circumstances, any arms, munitions, provisions, horses, horseshoes, livestock, or any of the goods that he is obligated to take on the expedition, in accordance with the terms of his contract, whereby there may result some fraud in the review and inspection. And if any person shall have received any of the above items from him as a loan, he must at once manifest them before the commissary general, under the penalty that whoever violates this decree and loans him anything must pay twice its value, to be applied to the expenses of war, and be deprived forever of any royal office in the army or elsewhere, as persons

acting against the royal service of his majesty. It is just that they should know what each one of those who is going to serve in this expedition is taking along and that each one personally must reveal what he has. In order that all may be informed of this notice, the commissary orders that it be publicly proclaimed in the plaza de armas, at the guard post, and in two other places of the camp most frequented by people. He attached his name to it. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

PUBLICATION

With the army which is at present in this valley of San Bartolomé, Santa Bárbara, and which is going to the discovery and conquest of New Mexico, on November 23, 1597, I, the royal notary, . . . ordered this decree proclaimed in the camp, at the guard post, the plaza de armas, and at other places when most of the soldiers and officials of the army were present. It was proclaimed by the town crier. I so certify. JAIME FERNÁNDEZ, royal notary.

THIRD SUMMONS

In the valley of San Bartolomé, Santa Bárbara, on November 30, 1597, Juan de Frías Salazar . . . stated that since he has twice summoned and instructed Governor Don Juan de Oñate to get ready for the review and inspection which he is to conduct, in compliance with the commission from his lordship, the viceroy, and since it is proper for the fulfillment and proper dispatch of the expedition that there be no delay from which inconveniences might ensue, he ordered and instructed me, the notary, to summon Governor Don Juan de Oñate for a third time to break camp in this valley and set out on his way with the people and goods which he is to bring, in order that the commissary general may be able to hold the review and inspection, which he is ready to do, at the place and locality that he deems most suitable for the service of his majesty. For this purpose he and his officials are waiting. He so decreed and signed. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

NOTIFICATION

With the army of New Mexico, in the valley of San Bartolomé, on November 30, 1597, I, the royal notary, brought the preceding decree to the attention of Governor Don Juan de Oñate, who said that he would reply to it. I so certify. Jaime Fernández, royal notary.

FOURTH SUMMONS

In the valley of San Bartolomé, Santa Bárbara, on December 5, 1597, Juan de Frías Salazar . . . ordered me, the present notary, to issue a fourth summons to Don Juan de Oñate . . . in the same manner as on previous occasions, to break his camp and get ready for the review, inspection, and inventory. Since the commissary has been detained and waiting so long for this purpose, in spite of the fact that he has summoned the governor many times, as is shown by the notices sent him, the governor must explain the reasons for the delay in order that he may notify his lordship, the viceroy. The commissary warns and reminds him that if any damage or inconvenience should result from this delay, it would be at his risk and not at that of the commissary general, since the latter is ready and prepared to hold the review and inspection at the place and location most befitting the service of his majesty. He so ordered and signed. JUAN DE FRÍAS SALAZAR. I so certify. JAIME FERNÁNDEZ, royal notary.

NOTIFICATION

In the valley of San Bartolomé, Santa Bárbara, where the army and expedition for New Mexico is encamped, on December 5, 1597, I, the royal notary, notified Don Juan de Oñate . . . of the preceding summons. After listening to it, he replied that he answers the same as previously. Further, he says that he is suffering great damage in being taken from this place, where, according to his capitulations, he was obliged to manifest what he was taking; moreover, at this place he had unloaded the carts and placed in storage all the things that he had brought to fulfill his contract. Since these supplies are so many and of such diverse kinds, it was necessary to unload and store them. And even though the damage being done to him is so well known, none the less, from the moment that the first summons was read to

him, neither he nor his army had lost any time in the work of again loading and arranging everything necessary to undergo the review at whatever place the inspector might order. Accordingly, the work is being completed so that he will set out with his whole army during the coming week. Wherefore, he asks me, the notary, to inspect and observe the entire force to see how the people everywhere are getting ready, working and packing, without neglecting any detail. So, to comply better with what his majesty orders and commands through the commissary general, he will submit to the review at the place and locality required. This was his answer, and he signed it. Don Juan de Oñate. I so certify. Jaime Fernández, royal notary.

DECREE

In the valley of San Bartolomé, Santa Bárbara, on December 5, 1597, Juan de Frías . . . instructed me, the notary, to summon Don Juan de Oñate . . . not to divide the people or equipment in his army, but, on the contrary, to bring the force out in a body, not leaving behind anything that he is supposed to take along and which is to be reviewed and inspected, for this befits the service of his majesty and the proper dispatch of the review and inspection. Further, he warned him not to grant permission to anyone to turn back, or send any soldier or other person in the army back to the settled area, since he knows that his grace is waiting to hold the inspection and review. Furthermore, in regard to the many damages and offenses committed against the subjects of his majesty by some soldiers and officials of his army throughout the country wherever they have passed, and in regard to those who left yesterday, he must recall them at once, with the warning that if they do not obey he will notify the viceroy and take whatever action is necessary. He so decreed. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

NOTIFICATION

In the valley of San Bartolomé, Santa Bárbara, where the army for the conquest of New Mexico is encamped, on December 5, 1597, I, the notary, transmitted the preceding summons to Don Juan de Oñate. . . . He replied that, as to the army's setting out at once and its not being divided, he would obey. As for

granting no one permission to turn back, this suits him very well, and if he should have to grant any exception, it would be for some appropriate reason and after consulting the commissary general. Concerning those who left yesterday, the reason was that Captain Juan Domínguez agreed to go on the expedition to New Mexico, provided that he be given an appointment as captain, which position the governor had offered to give him if he were present at the review, otherwise he would not be given the captaincy nor would he be accepted in the expedition. The two soldiers with him, it is affirmed in the camp, went to help him bring his belongings, but without the governor's permission. This was his answer, and he signed it. Don Juan de Oñate. I so certify. Jaime Fernández, royal notary.

PROCLAMATION

By order of Don Juan de Frías Salazar . . . all persons who are going on this expedition as captains, officials, soldiers, or in any other capacity, must, whatever their position or rank, appear personally before his grace and declare all the provisions, arms, munitions, horseshoes, iron articles, horses, mules, livestock, and anything else that they may be taking along and that may belong to them. It is desirable for the service of his majesty that a statement be made of what each one is bringing on his own account for use on the expedition, which must be done within four days from this date under penalty of forfeiting anything that is not shown and losing the right of being assigned encomiendas in the said provinces, without express authority from his majesty or the viceroy of this New Spain in his name. In order that everyone may be informed of this decree, he ordered that it be publicly proclaimed in the plaza de armas and at two other places of the said camp and that a copy of it be posted at the guard post or plaza de armas. Juan de Frías SALAZAR. I so certify. Jaime Fernández, royal notary.

Publication

I CERTIFY that this decree was proclaimed as ordered, by the blowing of bugles and by a town crier, and that it was also posted at the guardroom, on the day, month, and year stated above. JAIME FERNÁNDEZ. roval notary.

MANIFESTATION

In compliance with the above proclamation, some officials and soldiers of the camp presented lists of their horses, arms, and other things before his grace, the commissary general, and before me, the notary, a procedure which the commissary general deemed desirable in order to be able to hold a more accurate review and inspection of Governor Don Juan de Oñate. As this record was very voluminous, it is not entered here. These men swore that everything contained in their lists was correct, since it was not brought to be seen. In testimony of the truth, JAIME FERNÁNDEZ, royal notary.

PROCLAMATION

By order of Juan de Frías Salazar . . . no soldier, official, or any other person, whatever his rank or position, may go ahead without his order, under penalty of death, for this befits the service of his majesty. Under the same penalty, they are forbidden to move any animals, horses, mules, mares, or any other beasts or livestock until he, or someone delegated by him, has first examined them.

Valley of San Bartolomé, December 9, 1597. In order that this proclamation may be known to all, he orders that it be published. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

PUBLICATION

On this day, the above decree was proclaimed near the guardroom and the strong cart² of Governor Don Juan de Oñate. Witnesses were the sargento mayor, the alférez real, and other persons. Before me, Juan Pérez de Donís, secretary.

THE EXPEDITION SETS OUT

In the valley of San Bartolomé, Santa Bárbara, December 9, 1597, Juan de Frías Salazar . . . stated that although he had often summoned Governor Don Juan de Oñate to break camp and leave the place in this valley where he was encamped, he had not done so. He was delaying his departure, maintaining that it was his privilege to undergo the review at that place,

and that he was not ready to leave there; but, as the place was not suitable for holding the review, the commissary general had ordered him, as has been stated, to move the camp in order to hold the review elsewhere in a place more befitting the service of his majesty. Today, on the above date, the governor set his camp in motion, the entire force moving out. And in order that it be of record, he ordered me, the notary of the inspection, to set it down, and he signed it. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

CERTIFICATION

In compliance with this information, I, Jaime Fernández, royal notary of the inspection, certify that although the commissary general several times ordered Don Juan de Oñate by decrees to break camp and leave this valley of San Bartolomé, where he had found it, he did not do so until today when he began to move his whole force and to march forth with it. He actually began to move yesterday, but this was only a portion of the expedition, not all of it. I signed it on the above date [December 9, 1597]. Jaime Fernández, notary.

DECREE

In the valley of San Gregorio [sic], province of Santa Bárbara, on December 21, 1597, Juan de Frías Salazar . . . ordered and instructed me, the royal notary and secretary of this inspection, to summon and notify Don Juan de Oñate . . . that tomorrow, Monday, the 22nd of this month and year, his grace, the commissary general, wished to begin the inspection, review, and inventory to which Don Juan is obliged to submit, of all the provisions, arms, and munitions that he is to take on the expedition. The inspection will begin at the San Gerónimo river, a league more or less on this side of the mines of Todos Santos, this being a place well suited for the purpose of beginning the inspection of certain things which he feels can best be examined there. Other items will be inspected where he deems it most fitting to the royal service, and for this reason the governor must get ready. He so ordered and signed. JUAN DE Frías Salazar. I so certify. Jaime Fernández, royal notary.

NOTIFICATION

At the San Gerónimo river, province of Santa Bárbara, on December 21, 1597, I, royal notary, . . . summoned Governor Don Juan de Oñate and transmitted to him the preceding decree of the commissary general; the governor said that he accepted it and would comply. Witnesses were Alonso Núñez, Captain Gregorio César, and others. Jaime Fernández, royal notary.

DECREE

At the San Gerónimo river, province of Santa Bárbara, on December 20, 1597, Juan de Frías Salazar . . . ordered that, to inspect and make an inventory of the cattle that Don Juan de Oñate . . . was obliged to provide, it was appropriate and necessary for the royal service of his majesty and for greater clearness of the review that it be attended by two experienced ranchers, owners of cattle, to identify and explain the brands of the cattle and to give other pertinent information. Bartolomé Delgado, a resident of Nombre de Dios, and Juan Sánchez de Ulloa, resident of the mines of Todos Santos, were appointed, and he ordered them to be present at the inspection, to take their oath in due form, and to serve well and faithfully, without fraud or concealment of anything. He so ordered and signed. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

NOTIFICATION

On the aforesaid day, month, and year, I, royal notary, notified Bartolomé Delgado and Juan Sánchez de Ulloa personally of the preceding order. They replied that they accepted it and would obey. They took their oath in due form in the presence of the commissary general. JAIME FERNÁNDEZ, notary.

DECREE

At the San Gerónimo river, Santa Bárbara, on December 22, 1597, Juan de Frías Salazar . . . observed that since he wishes to start the inspection today at this place and examine and inventory some of the goods and equipment that Don Juan de Oñate . . . is under obligation to take, therefore, in order

that the inspection and inventory may be accurate and that all may be done in a manner befitting the service of the king, he ordered Don Juan de Oñate, under oath, to declare whether the goods and equipment that are to be examined are all his or if any have been loaned, given, or sold to him confidentially or in any other way to meet the requirements of the inspection, whereby something harmful to the royal service might result and thus some part of what Don Juan is under contract to provide might not be fulfilled. Let him take his oath with the required exactness and detail, and let it be understood that his declaration must comprise all of the goods covered by the capitulation, without the necessity of any further oaths for the entire inspection, this one embracing the entire proceedings. He so ordered and signed. Juan de Frías Salazar. Jaime Fernández, royal notary.

NOTIFICATION

At the San Gerónimo river, where the army on its way to the discovery of New Mexico is encamped, on December 22, 1597, I, royal notary, . . . personally read the preceding decree to Governor Don Juan de Oñate. After hearing it, he said that he would comply. He immediately took his oath in due form by the sign of the cross, stating that all of the things which he had to declare and present in the inspection, according to his obligations, were his own and had not been loaned or sold in confidence or obtained by fraud, contrary to the service of his majesty or to the fulfillment of his obligations. He said that he would not in any way accept or ask for any such things from the beginning of the inspection until it was completed. He took his oath in due form and signed in the presence of the commissary general, who also signed.

Governor Don Juan de Oñate said further that he appointed in his place the contador, Alonso Sánchez, who was present in the camp, to represent him and assist with the inspection, and that the necessary inquiries should be referred to him. To this end he granted him full powers, as the law prescribes in such cases, and he signed. Witnesses were Captain Luis Guerrero, Captain César, and others. Juan de Frías Salazar. Don Juan de Oñate. Jaime Fernández, royal notary.

THE INSPECTION IS BEGUN

AT the river of San Gerónimo, where the expedition to New Mexico is encamped, on December 22, 1597, Juan de Frías Salazar . . . after having received in due form the oath of Don Juan de Oñate, . . . began the inspection in the following manner:

First, he declared 87 fanegas of maize, which were measured in the presence of the commissary general and me, the notary; further, 18 fanegas, which Pedro Sánchez de Chaves declared under oath that he had sold him, and which were delivered to him in my presence at the mines of Todos Santos. The total is 105 fanegas, valued at 236 pesos and 2 tomines, priced at 18 reals the fanega, according to the valuation fixed in Mexico by the persons named for the purpose, 236 pesos, 2 tomines.

Wheat: On this same day the governor declared 152 fanegas of wheat, which were measured in the presence of the commissary general and me, the notary. According to the price fixed, this amounts to 380 pesos, leaving a shortage of 125 pesos in the amount required in the contract.

Goats: On December 23 of this year, the governor declared 846 goats and bucks, from which 130 were deducted as they seemed to belong to private individuals. There remained as the property of the governor 716, leaving a shortage of 284 to complete the 1,000 that he had agreed to provide.

Oxen: On this day the governor declared 198 oxen for the carts, which was his agreement.

Sheep: On December 24, the governor declared 2,517 sheep, among them some one-year old lambs, leaving a shortage of 483 to complete the 3,000 that he had agreed to provide.

Rams: Today Juan Sánchez de Ulloa declared under oath and in the presence of the commissary general and me, the notary, 383 rams, leaving a shortage of 617 to complete the 1,000 he had agreed to provide.

Colts: On December 26, the governor declared 96 colts, 54 short of the 150 that he had agreed to provide.

Mares: On this day the governor declared 101 mares, 49 short of the 150 that he had agreed to provide.

Mules and jackasses: On December 27, the governor declared 41 mules and jackasses, which he had agreed to provide for his two carts and two state coaches,³ twenty of them being pack animals.

Iron: On December 28, the governor declared 4,890 horseshoes for horses, mules, and asses, and 79,000 horseshoe nails. Among these items were 39 dozen pairs and 21 shoes for asses. At the rate of 48 horseshoes and 300 nails to a dozen pairs, this, at 12 pesos per dozen pairs, amounts to 439 pesos.

Of the shoes and nails for horses and mules, there were in this lot 128 dozen pairs, figured at 24 horseshoes and 200 nails per dozen pairs. Reckoned at the appraisal of 9½ pesos per dozen pairs, this amounts to 1,225 pesos. There were in addition a surplus of 21 horseshoes and 43,750 nails, which, according to the appraisal, amount to 350 pesos.

Consequently, by balancing the shortage in the one category with the surplus in the other, these horseshoes and nails, according to the appraisal of each lot, were worth the 2,000 pesos he had agreed to provide, with a surplus of 14 pesos.

Iron tools: On this day he declared 35 plowshares, which, appraised at 81/2 pesos each, amount to 298 pesos, 4 tomines.

Three hoes, appraised at 4 pesos each, 12 pesos.

Ten adzes, appraised at 21/2 pesos each, 25 pesos.

Eight small saws, one of them somewhat larger, about four spans in length. Although so small, they were appraised at 3 pesos, the same as those measuring six spans, 24 pesos.

One dozen chisels, appraised at 2 pesos each, 24 pesos.

Seventeen augers large and small, at 2 pesos each, 34 pesos.

Thirty-nine axes, with round eye, at 3 pesos each, 117 pesos. Six axes of poorer quality, with narrow eye, at 2 pesos each, 12 pesos.

Three padlocks, with staples and keys, at 4 pesos each, 12 pesos.

As some other iron tools were declared by the governor, the prices of which were not specified, the commissary general appointed Cristóbal Ruiz Aragonés and Antonio Rodríguez, merchants, to appraise them under oath. They set the following valuation:

Nine tools declared by the governor consisting of hammer, tongs, and hoof-parers, at 4 pesos each, 36 pesos.

Two hoof-parers, at 2 pesos each, 4 pesos.

Twenty-six cowboy goad sticks, appraised at 4 reals each, 131/2 pesos.

Five Torregar blacksmith hammers, valued at 5 pesos each, 25 pesos.

Two anvils, each appraised at 6 pesos, 12 pesos.

Three Fregenal knives at 1 peso each, 3 pesos.

Two hooked blades,* at 4 pesos each, 8 pesos.

Thirty-two arrobas and twelve pounds of iron made into small sledge hammers, bars, picks, and mallets, appraised in Mexico at 4 reals per pound, 406 pesos.

As a result, all of the iron goods declared by the governor, according to this list, amount to 1,065 pesos, leaving a surplus of 465 pesos more than the 600 he had agreed to provide.

Iron for making into goods: On this day the governor declared 114 arrobas and 15 pounds of iron for making into sheets, rods, and barrel hoops, amounting to 28½ quintals and 15 pounds. This was to satisfy the 600 pesos' worth of this type of iron which he had agreed to provide and which, at 20 pesos per quintal, should have been 30 quintals, a shortage of six arrobas and ten pounds.

Steel: On this day the governor declared one arroba and twenty pounds of steel, which, since it was not in his contract and had not been appraised in Mexico, was valued by the appraisers named by the commissary general at 5 reals per pound, the whole amounting to 28 pesos, 1 tomín.

Short nails: On this day the governor declared 13,500 short nails, which were weighed before the commissary general and me. The manner of weighing was to count 1,000 nails and place them in one dish of a balance, while in the other were added the exact weights. This was how it was established that there were 13,500 nails. As this article had not been listed in the governor's contract, nor in the appraisal made in Mexico, the aforesaid appraisers appointed by the commissary general valued them at 10 pesos per thousand, the whole amounting to 135 pesos.

Footgear: On December 29 the governor declared 251 pairs of cordovan leather shoes, which, appraised in Mexico at 9 reals per pair, amount to 282 pesos and 3 tomines. He also declared nine small pairs of the same, which, at 4 reals each, amount to 41/2 pesos; further, six pairs of cordovan boots with double soles-I mean thirty-six pairs-appraised in Mexico at 4 pesos per pair, 144 pesos; further, twenty pairs of cordovan buskins, at 3 pesos per pair, 60 pesos; further, three tanned goatskins, at 4 pesos each, 12 pesos; further, nineteen pairs of white waxed buckskin boots, at 3 pesos per pair, 57 pesos; further, thirty-six pairs of calfskin boots, at 2 pesos per pair as appraised in Mexico, 72 pesos; further, forty-one pairs of double-soled calfskin shoes, or three dozen and five pairs, which, at 5 pesos per dozen, amount to 17 pesos. Further, 413 pairs of single-soled calfskin shoes, or thirty-four dozen and five pairs, at 4 pesos per dozen, 137 pesos and 4 tomines. All of the aforesaid footgear, at the stated prices, amounts to 786 pesos and 3 tomines, leaving a surplus of 286 pesos and 3 tomines over the 500 pesos that he had agreed to provide.

Paper: On this day the governor declared forty-one reams of paper, of twenty quires each, and thirteen additional quires, which, at 5½ pesos per ream, amounts to 228 pesos, leaving a surplus of 28 pesos over the 200 that he had agreed to provide.

Wine: On this day the governor declared four barrels of wine. To make sure that it was wine, the commissary general ordered the barrels tapped in my presence. Since Captain Villagrá was the one who had brought it, he swore that each barrel contained four arrobas, which was affirmed by the contador, Alonso Sánchez. As this item was not in the contract, it was appraised under oath by the aforesaid appraisers, at 14 pesos per arroba. At this price the sixteen arrobas amount to 224 pesos.

Oil: On this day the governor declared fifteen jugs of half an arroba each. The governor swore that they contained oil, and because they were sealed and there was risk of loss, and also because this item was not listed in the contract, they were not opened. The oil was appraised at 6 reals [sic] per arroba, so the seven and one-half arrobas amount to 45 pesos.

Sugar: On this day the governor declared fifty-six pounds of sugar in cakes, and, since it was not listed in the contract nor

its price fixed, it was valued by the appraisers, at 8 pesos per arroba, a total of 18 pesos.

Sundry articles: On this day the governor manifested the articles listed below, and, as it seemed to the commissary general that he was taking them for the people in his service, he did not order them appraised.

Five chamois doublets of poor quality, unused, and five pairs of sleeves of the same material; seven doublets of Chinese gray Holland cloth, and five pairs of sleeves of the same material; nine doublets of very coarse Anjou cloth; twelve pairs of white woolen stockings from the market, poor quality, which the commissary said sold at 3 reals; four white huipils4 from Xochimilco; five coarse woolen huipils; three pairs of woven petticoats; three pairs of embroidered petticoats; ten acintres [word partly illegible] for the trimming of huipils; four and a half rolls of cotton goods containing twelve yards each; three of Campeche cloth; one roll of Holland cloth containing eight yards; one roll of native black taffeta of thirty-five yards; one roll of black Chinese damask of eleven yards; one roll of yellow Chinese taffeta of twelve yards; five yards of Chinese taffeta of iridescent color; another roll of green Chinese taffeta of nine yards; eight yards of native London cloth; ten yards of native cloth of mixed materials; five yards of native, coarse gray cloth; seven yards of coarse white woolen cloth in two pieces; ten yards of coarse, native-blue cloth; twenty-one yards of native black baize.

Medicine: On this day the governor declared the following medicines and pharmaceutical goods: Six syringes, appraised in Mexico at 6 pesos and 6 tomines each, 22 pesos and 4 reals.

Six lancet cases, with two lancets in each, at 1 peso, 6 pesos. Four pounds of cassia fistula—I mean ten pounds; accordingly, the ten pounds, appraised at 10 pesos for twenty-five pounds, amount to 4 pesos.

Fourteen and one-half pounds of sarsaparilla, at 4 reals per pound, 7 pesos and 2 tomines.

Five pounds of green ointment, according to the labels on the containers and the testimony of Juan del Cazo, at 1 peso per pound, 5 pesos.

Three and one-half pounds of incarnative ointment in a container, appraised at 15 tomines per pound, 6 pesos and 41/2 tomines.

Two and one-half pounds of *jeziaco* ointment, at 2 pesos and 4 tomines per pound, 6 pesos and 2 tomines.

Four pounds and four ounces of basilicon ointment, at 2 pesos per pound, 8 pesos and 4 tomines.

Four more pounds of the same ointment, 8 pesos.

Three pounds of white ointment, at 15 reals per pound, 5 pesos and 5 tomines.

Two pounds and six ounces of laxative, at 3 pesos and 6 tomines per pound, 9 pesos.

One pound and two ounces of rose extract, 2 pesos and 2 tomines.

One pound and two ounces of Toledo treacle, at 8 pesos and 6 tomines per pound, 9 pesos and 6 tomines.

Four pounds of balsam, at 3 pesos per pound, 12 pesos.

Two and one-half pounds of diachylon, at 2 pesos and 4 tomines per pound, 6 pesos and 2 tomines.

Half a pint of rose water, at 6 tomines and 3 grains per pint, 3 tomines and 11/2 grains.

One pint of rose vinegar, 6 tomines and 3 grains.

Twelve ounces of sulphur, 6 tomines.

Fifteen and a half ounces of alum, 1 peso.

Five ounces of *polvos reales*, at 5 pesos per pound, 1 peso and 2 tomines.

Three ounces of mastic, 4 tomines.

Four and a half ounces of verdigris, 1 peso.

According to the labels of these medicines, the testimony of Juan del Cazo, and the examination by the commissary general, the medicines here listed are those that were found and are worth 125 pesos. This leaves a shortage of 375 pesos from the 500 he had contracted to provide.

Hogs: On this day the governor declared 53 hogs, large and small, male and female, two of them lame, a shortage of 47 from the 100 he had agreed to provide.

Articles for barter: On the last day of December of the said year, 1597, the governor declared the following articles for barter:

Three bunches of glass beads, blue, black, and other colors, each one containing 10,000 beads. At 6 tomines and 3 grains per bunch, they are worth 2 pesos, 2 tomines, and 9 grains.

Twenty-five ordinary combs, artificial, appraised at 7½ grains each, 1 peso, 7 tomines, 2½ grains.

Nine lots of Bohemian knives, consisting of eighteen knives in each lot, appraised at 5 tomines and 7½ grains per lot, 6 pesos and 1½ tomines.

Eighteen lots of butcher knives, ten knives in each lot, appraised at 2 pesos and 4 tomines per lot, 45 pesos.

Eighty-nine ordinary scissors, appraised at 3 tomines and 9 grains each, 41 pesos, 1 tomín, and 3 grains.

Nineteen small Flemish mirrors, appraised at 1 tomín and 6 grains each, 3 pesos, 4 tomines, and 6 grains.

Seven thousand two hundred and fifty shoemaker's needles, appraised at 1 peso and 2 tomines per thousand, 9 pesos and 6 grains.

Eighty-two and one-half dozen glass earrings, appraised at 3 tomines and 11/2 grains per dozen, 31 pesos, 4 tomines, and 6 grains.

Nine hundred glass beads called aquamarines, appraised at 6 grains per thousand, 5 tomines and 7½ grains.

Nineteen and a half dozen hawks-bells, appraised at 3 pesos and 1 tomín per dozen, 42 pesos, 7 tomines, and 3 grains.

He declared also the goods and articles listed below, but, as these were not appraised in Mexico, the commissary general ordered them appraised in his presence by Antonio Rodríguez, Cristóbal Ruiz Aragonés, and Captain Gregorio César, which they did, under oath, as follows:

Six hundred and eighty medals of an alloy, at 1 tomín each, and 238 smaller medals, at half a real each, 99 pesos and 7 tomines.

Six dozen jet rings, at 4 reals per dozen, 3 pesos.

Twenty-five rings of an alloy, at 2 reals each, 6 pesos and 2 tomines.

Twenty-two finger rings of bone, at 1 tomín each, 2 pesos and 6 tomines.

Twenty thimbles, appraised altogether at 20 reals, 2 pesos and 4 tomines.

Some wooden beads painted like coral, for seven rosaries, valued at 101/2 tomines, 1 peso and 21/2 tomines.

Thirty-one rosaries of glass beads, at 1 real and 3 grains each, 4 pesos and 7 tomines.

Twenty-three other rosaries of the same quality, 3 pesos, 4 tomines, and 9 grains.

Twenty-two necklaces of glass beads, at 3 reals each, 8 pesos and 2 tomines.

Forty-four throatbands of glass beads, at 2 reals each, 11 pesos.

Twenty-four necklaces of glass beads, at 11/2 reals each, 4 pesos and 4 tomines.

Seventeen necklaces of glass beads, at 2 reals each, 4 pesos and 2 tomines.

Forty-five hundred small glass beads called half aquamarines, at 3 tomines and 11/2 grains per thousand, 1 peso, 6 tomines, and 11/2 grains.

Seven small bunches of little white beads called Indian barley, at 2 reals per bunch, 1 peso and 6 tomines.

Forty-six bunches of small glass beads of 1,000 beads per bunch, appraised in Mexico at 6 tomines and 3 grains each, 3 pesos, 4 tomines, and 9 grains.

Six small gourd-shaped earrings of colored glass, at 1/2 a tomín each, 3 tomines.

Fifty-six Tlascala tassels for rosaries, at 1 tomín each, 7 pesos. Some beads of an alloy for throatbands, 2 pesos.

Four and a half dozen amulets made of badger bone, at 4 reals per dozen, 2 pesos and 2 tomines.

Eight pairs of whistles of Texcoco clay, 4 reals.

Thirty-one tin images, resembling an Agnus Dei, 4 pesos.

Sixteen tin medals, 1 peso.

Some small tinsel pictures, 1 peso.

Ten or twelve small glass buttons, 4 reals.

Six small flutes for children, at $\frac{1}{2}$ a tomín each, 6 tomines.

Six awls, at 2 reals each, 11/2 pesos.

One pound and six ounces of Castilian thread, blue and white, 3 pesos.

Seven ounces of coarse Portuguese thread, 2 pesos.

Five ounces of fine yarn, 2 pesos, 4 tomines.

One lot of Paris trumpets for children, 5 pesos.

One jet headpiece, 2 pesos.

Nine small hats, very poorly dyed, seven of them without lining or fringe trimming, 4 pesos and 6 tomines.

Accordingly, crediting the total sum of these trading articles, which amounts to 355 pesos and 7½ tomines, there is a shortage of 144 pesos and 6 grains from the 500 pesos called for in the contract.

Sackcloth and frieze: On January 2, 1598, the governor declared 441 yards of sackcloth, appraised in Mexico at 3 tomines, 1½ grains per yard of blue colored sackcloth of the kind manifested by the governor, 168 pesos, 5 grains.

The governor did not declare any frieze, as he said that he had made floursacks of what he had. Not considering the frieze, there is a shortage of 331 pesos, 7 tomines, and 7 grains to complete the 500 pesos' worth that he had contracted to provide.

Jerked beef: The governor stated that he had no jerked beef but that he wished to replace this item by some of the livestock as he thought that this would be more desirable. The commissary general answered that jerked beef was a better form of food, since it could be transported more easily, whereas livestock could be taken only where it could go on foot, with much labor. The governor was under obligation to provide 500 pesos' worth of jerked beef.

Bellows: On this day the governor declared six pairs of bellows, with iron pipes, for use in mines or blacksmithing; one large anvil; another large one and a smaller one; a large hammer, and a small one; one pair of tongs; all of these articles were of iron; eight files, large and small; three more small hammers; one vise for taking harquebuses apart; two other sets of bellows, without pipes; one small silversmith's bellows, equipped with small pipes.

In these goods the governor fulfilled his agreement and in addition had two sets of bellows, without pipes or wood, and the little ones indicated above.

Flour: On January 3, 1598, the governor declared 689 quintals, 3 arrobas, and 23 pounds of flour. Establishing the tare at eight pounds per bag, the flour was weighed by Captain Gerónimo Márquez, under oath, in the presence of the commissary general, who helped with the weighing, and in my presence.

To comply with his contract, the governor was required to bring 1,500 pesos' worth of corn and flour; discounting the corn that he manifested, according to the prices fixed in Mexico, and the flour, we must deduct 580 quintals, leaving a surplus of 181 quintals, 3 arrobas, and 23 pounds.

Cattle: On January 7, 1598, the commissary general inspected and listed the cattle manifested by Contador Alonso Sánchez, in the name of the governor. In order that the inventory might be made with the detail that was desired, he appointed as inspectors Juan Sánchez de Ulloa and Bartolomé Delgado, who took oath in due form that they would declare accurately the brands and markings of the cattle. This was done in the presence of persons who declared that they had cattle in the valley of San Bartolomé, at Santa Bárbara, and at Todos Santos. They also took oath and testified as to whether they had sold or loaned any cattle to the governor. The latter declared that Pedro Sánchez had sold him 215 head of cattle and had delivered them to Juan Díaz, resident of Todos Santos, and that Bartolomé Delgado had sold and delivered to him 1,000 animals, large and small. A certain number of cattle that were found with the Ontiveros brand and a few with unknown brands belonged to the governor and his people, they said. Although there were other cattle that belonged to private individuals, these were not listed, except as belonging to the proper owners, and the commissary general allowed the owners of these cattle to take them away. Of the cattle said to belong to the governor, the following were listed:

Of cows, steers, and bulls, which the inspectors said were full grown, although some said that they were only one and a half years old, they manifested 799 animals as belonging to the governor.

Calves: They declared also 500 calves, male and female, which they said were up to ten months old, some less than four months. He had agreed to take 1,000 head of cattle and said that he had complied by supplying the calves, but the commissary general insisted that they had to be full grown. The decision rests with his lordship.

Carts: On January 9, the governor declared twenty-four carts, equipped. He had agreed to take twenty, so he has a surplus American Journeys—www.americanjourneys.org

of four. The oxen for these carts are listed in his declaration of December 23, 1597.

A summary was made of the things furnished the governor by his majesty, such as artillery, powder, lead, and quicksilver, including the following:

Powder supplied by his majesty: On January 3, eighteen barrels of powder, which the governor had declared, were weighed and verified as powder when the commissary general had them tapped at both ends. Upon establishing the tare, it was found that there were 25 quintals, 3 arrobas, and 23½ pounds, leaving a shortage of 4 quintals and 1½ pounds to complete the 30 quintals that he had received.

Lead: On this day some lead sheets declared by the governor were weighed in the presence of the commissary general, and it was found that there were 78 quintals and 8 pounds, leaving a shortage of 21 quintals, 3 arrobas, and 17 pounds in the 100 quintals that he had received.

Quicksilver: On this day the commissary general asked the governor for an accounting of ten quintals of quicksilver which it appears that he had received from his majesty for this expedition; he presented ten barrels which he said contained five quintals. The commissary general opened one of them, and as he was an experienced miner, he said that it was quicksilver. He did not open the other barrels as there was danger that they would not be properly repacked. The governor said that he was under no obligation to give an accounting of this, since he had agreed to pay his majesty for it. There was a shortage of five quintals from the ten that he had received.

Greta: On this same day the governor declared a small amount of greta, which he said amounted to twenty pounds. Later Pedro Sánchez de Chaves swore that he had sold him twenty quintals at one peso per quintal. This is not listed in the capitulations, but the governor said that he would take it to make up for some of the shortage in lead.

Artillery: On January 9, the governor was asked for an accounting of the artillery, whereupon he declared three bronze fieldpieces, each of which had a shield with the royal coat of arms. He said that they were the same that had been given to

him in the name of his majesty. One of them had a visible inscription which read, 3 quintals, 3 arrobas, 5½ pounds; the other, 3 quintals, 2 arrobas, 20 pounds; and the third, 3 quintals, 3 arrobas, and 19 pounds.

Personal belongings: On this day the governor declared two carts with iron-rimmed wheels. The mules for these carts were declared on December 27. He had fulfilled his agreement.

State coaches: On this day the governor declared two state coaches, one completely equipped, the other without wheels; he said the latter had broken down and was being repaired.

Mules: On this day the governor declared twenty-five sets of harness, with pads and girths for the twenty-five mules that he had agreed to provide. The mules were included with others in the declaration of December 26. He had fulfilled the terms of the contract.

Saddles (sillas estradiotas): 6 On this day the governor declared the six saddles of this kind which he had agreed to provide.

Saddles (sillas jinetas): On this day he declared the six saddles of this kind which he agreed to provide, all completely equipped. One had blue and gold velvet trappings and silver trimmings; another had a green and gold velvet caparison; another had caparison and trimmings of crimson velvet; still another was of black velvet, and two were of cloth and ocelot skin. He had fulfilled his agreement.

Shields: On this day he declared the six leather shields that he had agreed to provide.

Lances: He declared the six lances that he had agreed to provide.

Halberds: He declared the twelve halberds that he had agreed to provide.

Harquebuses: He declared likewise the six harquebuses that he had agreed to provide.

Swords: He declared also the six swords and daggers that he had agreed to provide.

Corselets: He declared also the six corselets that he had agreed to provide; one was red, another white, and one was equipped with a Burgundian helmet and greaves.

Heavy saddles: He declared two heavy saddles (sillas de armas),7 according to his contract.

Buckskin jackets: He declared also five buckskin jackets and two of chamois [gamuza].

DECREE

At the river of San Gerónimo, where the army for the discovery of New Mexico is encamped, on January 7, 1598, Juan de Frías Salazar . . . stated that in order to continue the inspection with more clearness it was desirable for the service of his majesty that Governor Don Juan de Oñate declare under oath whether he had offered to furnish arms and horses to the soldiers listed below, who have stated that they do not have what is required and that the governor had promised to furnish it to them. These men are Don Juan Escarramad, a coat of mail; Francisco Cadino, everything he needs, and the same for Pedro de San Martín, Rodrigo Velmán, Cristóbal Pérez, Juan de Medina, Juan Jiménez, Diego Hernández, Alvaro de Barrios, Diego de Medina, Diego Landín, Francisco Vido, Cristóbal de Herrera, Antonio Conde, Alonso Martínez, Diego Castilla, Cristóbal Guillén, Francisco de Villalba, Isidro Juárez, Juan Guerra, Jorge de Zumaya, and Bartolomé de Herrera.

The governor must specify what he has promised to furnish each one. He so decreed and ordered. Juan de Frías Salazar. I so certify. Jaime Fernández, royal notary.

ARMS FOR SOME SOLDIERS

At the river of San Gerónimo, where the army which is going to New Mexico is encamped, on January 7, 1598, after Don Juan de Oñate had been notified of the preceding decree and after he had taken oath in due form, he stated that he had promised Francisco Vido, Cristóbal de Herrera, Antonio Conde, Alonso Martínez, Diego Castilla, Francisco Guillén, Isidro Juárez, and Juan Guerra all the necessary arms for the expedition, such as helmets with beavers, coats of mail, cuisses, harquebuses, horse armor, and two horses each. To Francisco Cadino, Pedro de San Martín, Jorge de Zumaya, and Bartolomé de

Herrera, he had promised a coat of mail, cuisses, casque with beaver, and two horses each; and to Cristóbal Pérez, Juan de Medina, Juan Jiménez, Diego Hernández, Alvaro de Barrios, Diego de Medina, and Diego Landín, coats of mail and beavers of mail; and to Don Juan Escarramad one coat of mail. All except the said Don Juan were to receive two horses each. After presenting these arms before his grace, the commissary general, for examination, they were distributed to these men in his presence. This is what he declared and signed. Don Juan de Oñate. I so certify. Jaime Fernández, royal notary.

Armor: On January 8, the governor declared as his own ten coats of mail, seven beavers, ten cuisses, and one harquebus. On the day of the review, these arms were carried by men unable to pay for them, wherefore the commissary general refused to accept them; moreover, he believed that some men who had been equipped by the governor had come to take part in the review and not to go on the expedition. Besides these and other arms declared by persons who took part in the inspection as being the property of the governor, he declared as his own one coat of mail, with beaver and cuisses, as is shown in the declaration of the ninth of this month.

Small-caliber gun: On this day the governor declared an iron small-caliber gun (esmeril), with chamber, and two small bronze pieces, with chambers. One weighed two arrobas and sixteen pounds, with chamber.

Horses: The governor declared 119 horses, good and bad. He said that of this number he had given two to each of nineteen soldiers. Discounting them by order of the commissary general, there remained to the governor 81 horses, a surplus of 66, I mean 56. They were not considered as army horses, for, among all of them, there was not a single one that looked like it, according to the commissary general, and a mere glance showed that they were old nags.

This inspection of all the things declared above was done faithfully and accurately by the commissary general, who attended to all of it in person and in my presence, to which I certify. The commissary general affixed his name to the report at Todos Santos. It was completed on January 10, 1598. Juan DE FRÍAS SALAZAR. JAIME FERNÁNDEZ, royal notary.

DECLARATIONS OF THE SOLDIERS

Francisco Vázquez: Articles taken by Francisco Vázquez, soldier, to serve his majesty on the expedition to New Mexico:

One harquebus and sword;

Two coats of mail;

Some small breastplates;

A short jacket of mail (jaco);

One cuisse, with helmet and beaver;

Some horse armor;

One mule:

Two jineta saddles.

All the aforesaid is mine and I am taking it for the purpose declared, and I so swear in due legal manner.

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, in the presence of the commissary general, Francisco Vázquez, soldier, made the above declaration under oath. The commissary general accepted this statement and affixed his rubric. Francisco Vázquez. Jaime Fernández.

JUAN MEDEL: Record of what I, Juan Medel, soldier, am taking on the expedition to New Mexico to serve his majesty:

One cart with five oxen;

Twelve horses:

One coat of mail, beaver, and cuisses of mail;

One harquebus:

One buckskin jacket;

One hooked blade (dalle);8

Two *jineta* saddles;

One sword.

All of this is mine, and I so swear in the name of God in due legal manner. The above does not include my personal clothes. JUAN MEDEL.

In the valley of San Bartolomé, in Santa Bárbara, December 7, 1597, Juan Medel made the above declaration before the commissary general under oath in due form. The commissary general accepted it and added his rubric. Juan Medel. Jaime Fernández.

8. The dalle or hoz was a hooked blade or curved cutting instrument like the modern sickle. See above, p. 137. We have not, unfortunately, found a contemporary description of the use for which this blade was intended.

JUAN ORTIZ: Statement of the arms and military equipment provided by Juan Ortiz Riquel to serve his majesty on the expedition to New Mexico:

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, Juan Ortiz Riquel made the above declaration under oath in due form. The commissary general accepted it, and added his rubric. Juan Ortiz Riquel. Jaime Fernández.

VILLA VICIOSA: Statement of what Miguel Pérez de Villa Viciosa, soldier, is taking to New Mexico in the service of his majesty:

First, one servant;

Then, my personal arms, consisting of a coat of mail, cuisses, harquebus, and horse armor;

One beaver and buckskin jacket;

Three jineta saddles and my sword;

One tent of thirty-four yards of frieze;

Three cavalry horses;

Two pack horses, with harness;

Five horses for the use of myself and servant.

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, Miguel Pérez de Villa Viciosa made the above declaration and swore to it in due form. The commissary general accepted it and affixed his rubric. MIGUEL PÉREZ DE VILLA VICIOSA. JAIME FERNÁNDEZ.

Gonzalo Hernández: I, soldier and caudillo on the expedition to New Mexico, state that I am going to serve his majesty, with my wife, one married daughter, and a son old enough to bear arms, and that I am taking along the goods that I have left; the rest has been used up, stolen, or lost.

One cart with six oxen;

Twelve horses, of various brands and marks;

Two harquebuses, fully equipped;

One coat of mail, beaver, and cuisses;

Some horse armor;

One jineta saddle and two bridles;

One tool kit for shoeing horses;

One sword for my personal use;

One hocking blade (desjarretadera);9

Two axes, two chisels, one adze, and one balance.

I am not including my clothing or that of my wife.

I swear by God and this cross that this record is faithful and true. Gonzalo Hernández.

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, Gonzalo Hernández made the preceding declaration and swore to it in due form before the commissary general, who accepted it and added his rubric. JAIME FERNÁNDEZ.

PEDRO SÁNCHEZ: Statement of all the articles and equipment brought by Pedro Sánchez Monrroy, soldier, for the expedition to New Mexico, in order to serve his majesty there with wife, children, and family, for which purpose he took the following:

Twenty-six horses for military use and for riding and packing, some of them being colts;

Two jineta saddles;

One estradiota saddle;

Five bridles;

Three pairs of cavalry spurs;

One coat of mail and one cuisse;

One helmet and beaver of fine mail, complete;

One short jacket and one buckskin jacket;

One harquebus, fully equipped;

9. The desjarretadera was a curved cutting blade, resembling the English billhook, which was evidently used for hocking cattle. The blade was the dalle or hoz and was attached to a long handle, probably to enable the soldier to get close enough to his prey. Throughout these documents we have adopted the term "hocking blade" to designate the weapon. The dalle or hoz, as noted previously, was something like our scythe or sickle and we have translated it sickle or hooked blade.

On December 7, 1597, Pedro Sánchez, soldier, declared the above articles and swore in due form that he had nothing else to present; the commissary general accepted the report. Pedro Sánchez did not sign because he said that he did not know how. Juan de Frías Salazar. Jaime Fernández.

Francisco Hernández: I, Francisco Hernández Cordero, soldier of New Mexico, in compliance with the decree of your grace, declare that I am going on the expedition with my wife and father-in-law, and that I bring the following arms and military equipment:

One set of iron tools:

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, Francisco Hernández Cordero, soldier, made the above declaration under oath in due form before the commissary general, who accepted it and affixed his rubric. Francisco Hernández Cordero. Jaime Fernández, notary.

Alonso Martínez: A complete set of armor for himself consisting of one coat of mail, cuisse, casque with beaver, helmet, harquebus with powder flasks, 11 a chamois coat, sword, one set of ten knives, one hocking blade, thirty horseshoes with 200 nails, eight horses, four of them with complete horse armor, one jineta saddle, three pairs of boots, and two of shoes. Alonso Martínez.

On December 7, 1597, Alonso Martínez made the preceding declaration under oath in due form and stated that he had nothing else to manifest. The commissary general accepted it and added his rubric. Alonso Martínez. Jaime Fernández, notary.

Gonzalo de la Carrera: Statement of the articles taken by Gonzalo de la Carrera on the New Mexico expedition to serve his majesty:

Six horses;

One harquebus;

One coat of mail, one casque with beaver:

Some cuisses;

Antonio de Seriñana: I, Antonio de Seriñana, soldier, declare that I am going to serve his majesty in the expedition to New Mexico with my arms and horses, which I am ready to declare in obedience to the decree of your grace. The items are as follow:

This declaration does not include my silks, clothes, silver, or jewels or those of Doña Beatriz Navarro, my wife, because I do not wish to include them here. Besides the cattle and war materials that I am listing and which I possess now, an equal amount has been used up, stolen, or lost because of the delay of the expedition. I so swear by God in due legal manner. Signed, Alonso de Sosa Albornoz.

In addition, the captain declared four dozen pairs of shoes, four pairs of buskins, four pairs of Flemish boots, six pairs of those made here, and twenty-five quintals of flour.

I, Juan Pérez de Donís, a resident of the city of Mexico in New Spain, and married there, with sons and daughters, a son-in-law and grandchildren, all of a noble and distinguished family, state that in compliance with the decree published today by order of your grace, summoning all persons who are going on the expedition to present a statement of the things that they are taking to New Mexico in the service of his majesty, I am going with the following:

Sword, harquebus, coat of mail, cuisse, beaver, and helmet, and six cavalry horses. The harquebus is fully equipped.

Further, I am taking one complete set of buckskin horse armor, lined with rawhide. I am not listing my clothes or linens as there is no need to do so.

Further, I call to the attention of your grace that in the review of Governor Don Juan de Oñate made by Don Lope de Ulloa y Lemos, I offered that, as secretary of the second expedition and of the government of those kingdoms, I would bring my wife, Doña Anna de Herrera, and my son, Fray Gonzalo de Herrera, preacher and teacher in the order of St. Augustine, and two grown sons, lay brothers, two maiden daughters, and a married daughter, to live and settle in those kingdoms, but that this offer could not be carried out on account of the delay of the expedition; nevertheless I now renew the offer.

Further, I declare that for nearly three years I have been serving his majesty as secretary and royal notary of the expedition and was the first to offer my services in that enterprise; it was in my presence that it was announced and that the governor took his oath of fealth without my receiving any reward. I have

endured many privations and hardships, as I shall prove at the proper time and place. For this reason, my wife and family are poor and in dire need. I so swear by God and this cross in due form. Juan Pérez de Donís.

In the valley of San Bartolomé, Santa Bárbara, December 5, 1597, Juan Pérez de Donís, secretary of the expedition to New Mexico, presented the preceding statement to the commissary general and swore in due form that nothing he possessed had been loaned, and that he had nothing else to declare. The commissary general affixed his rubric. Juan de Frías Salazar. Juan Pérez de Donís. I so certify. Jaime Fernández, royal notary.

FELIPE DE ESCALANTE: Statement of the military equipment and everything else that I, Captain Felipe de Escalante, am taking on the expedition to New Mexico in the service of his majesty:

First, nineteen horses, of various brands and colors, marked with my brand, which is shown in the margin;

Seven mules, with the same brand;

A set of bellows for use in smelting silver;

Three pickaxes;

One sledge hammer;

Six axes for cutting wood;

Two chisels:

Three adzes:

One auger;

Eight dozen pairs of horseshoes and nails;

Two thousand nails;

One soldier, at my expense;

Two coats of mail;

Two pairs of breeches of mail;

Two helmets, with beavers;

Twenty-five pounds of powder;

Two sets of horse armor;

Five jineta saddles for myself and my people;

One harquebus;

One estradiota saddle;

One iron of a machine (ingenio) for extracting silver;

My sword;

Three machetes, as presents for Indians;

Two hooked blades for my people;

One hocking blade.

All of this I am taking on the expedition to serve his majesty. I swear by God and this cross that everything I have here stated is true. Nor am I including many other goods that I have sold in order to support and maintain my people and soldiers for a period of more than two years while we have been detained at this place. Here I am, waiting to serve his majesty as a first discoverer of that land, which I was. In the past, I spent large sums of money exploring it by order of the Count of Coruña, and I say further that none of the other discoverers of that land are going to serve his majesty on this expedition.

I am taking also one tent. I am not including here the clothes for my personal adornment, nor the linens. Felipe de Escalante.

In the valley of San Bartolomé, Santa Bárbara, December 5, 1597, Captain Escalante presented the above statement under oath before the commissary general, who accepted and signed it. JUAN DE FRÍAS SALAZAR. FELIPE DE ESCALANTE. JAIME FERNÁNDEZ, notary.

ALFÉREZ DOMINGO DE LEZAMA: Statement of the military equipment that I, Domingo de Lezama, am taking and which I declare by order of the inspector, Juan de Frías Salazar:

First, twelve horses, four of them for cavalry;

One riding mule;

Two harquebuses;

Some horse armor;

One coat of mail, beaver, and cuisses;

One buckskin jacket;

Another strong jacket of chamois;

One lance, one hooked blade, and one javelin;

Three saddles, two jineta and one estradiota;

One sword;

Thirty horseshoes and 800 nails.

All of this I am taking for my personal use. I swear by God and this cross that this is a true statement and that I have all that is here recorded. Done on this day, December 6, 1597. DOMINGO DE LEZAMA.

MARTÍN RAMÍREZ: Statement of what I, Martín Ramírez, am taking on the expedition to New Mexico in the service of his majesty:

One shotgun, with its accessories;

One coat of mail, with cuisse and beaver;

Some horse armor;

Eight tame horses;

Two saddles, one *jineta*, the other for bridle (brida);

One sword.

PEDRO DE SAN MARTÍN: Statement of what Pedro de San Martín is taking to serve his majesty on the expedition to New Mexico:

The other arms, for person and horses, were promised to me by the governor, Don Juan de Oñate. I so swear in due legal manner. Pedro de San Martín.

In the valley of San Bartolomé, Santa Bárbara, December 6, 1597, Pedro de San Martín, soldier, made the above statement and swore to it in due form. The commissary general accepted

it and affixed his rubric. Pedro de San Martín. Jaime Fernández, notary.

I, Francisco de Sosa Peñalosa, captain and alférez real of this army which is going to New Mexico, state that I left the mines of Chalcheutes to serve his majesty on this expedition with my wife and children, servants, arms, horses, mules, mares, carts, one hundred oxen, four hundred quintals of flour, two pipes of wine, and other provisions. Because of the delay of the expedition—it is going on two years since I assumed this post—my provisions have been used up, and many of my horses, mares, mules, oxen, arms, and many other things have been lost or stolen. But, in compliance with the decree proclaimed by order of your grace, I declare here what is left, without including my personal effects and those of my wife and children, or my home, which are of considerable value. My declaration is as follows:

First, myself and my wife, Doña Euphemia; my daughter, Doña Juana de Trejo, married to Diego de Zubía, captain and purveyor of this army; my son, Francisco de Sosa Peñalosa, 24 years old; my son, Estevan Illán de Sosa, 21 years of age, married to Doña Juana de Argüello.

Arms for myself and my two sons consisting of three coats of mail;

Three pairs of cuisses;

Three helmets with beavers;

Three harquebuses with accessories;

Three swords, one strong leather jacket;

Three complete sets of buckskin horse armor, including shields;

Three *jineta* saddles, with caparisons of ornamented cloth;

Three estradiota saddles, with bridles and spurs;

Two sidesaddles of ocelot skins, with bridles of the same material:

Twelve carts, with the one hundred oxen I have declared, less those that have been lost, the number of which I do not know;

One large tent of frieze;

One outfit of bellows with iron pipes;

Tools consisting of axes, hoes, and adzes;

Forty horses and mules that I brought with me, but until the roundup is made and we start out, I do not know how many there will be;

Thirty mares and some jackasses;

Three female negro slaves;

One mulatto slave, and other men and women servants in my household;

One box containing a complete set of sacred vestments for saying mass;

Seven hundred pesos' worth of silver articles for my personal

I swear by God and this cross that this statement is faithful and true. Francisco de Sosa Peñalosa.

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, the alférez real, Francisco de Sosa, made the above declaration before the commissary general, who accepted and signed it. Francisco de Sosa Peñalosa. Jaime Fernández, notary.

Contador Alonso Sánchez: I, Alonso Sánchez, contador of the public treasury and a member of the council of war for the provinces of New Mexico, state that according to the decree published by order of your grace, all of us who are going on the expedition to New Mexico must give a report of the articles and goods that we are taking to serve his majesty there. Without listing the clothing, linens, and other things that I am taking for the adornment of myself, my wife and children, and all that has been used up or stolen to the present—which is twice as much as I now have—because of the long delay in the dispatch of this expedition, I report that I have the following:

First, four carts, with thirty-five tame draft oxen with my brand, which is given in the margin, and other brands, as I bought them from different people;

Thirty-five horses for army duty and other service in the expedition, among them some colts marked with my brand and that of the breeder from whom I bought them;

Two mules, with my brand; two asses and two she-asses; forty mares and a jackass;

Fifteen tame cows;

Three complete sets of horse armor;

Two coats of mail;

Four helmets with beavers;

Two pairs of cuisses, three harquebuses with accessories;

One pistol;

Six jineta saddles and one for bridle, all complete with stirrups, girths, and everything necessary;

Twelve bridles and eight pairs of spurs;

Four pairs of reins;

One hundred pounds of iron, in goods and plain iron;

Three frying pans and two iron comales;

Two big copper kettles, and one ladle and one olla;

Four barrels for water;

Four swords;

Three jugs of oil;

One barrel of wine;

Five sets of butchering knives;

Two buckskin jackets and two of chamois;

One set of tools for shoeing horses;

Five augers, large and small;

One ax;

Two adzes:

One saw;

A pair of iron pipes and a blower;

Two chisels.

In addition to what is listed here, I declare that I brought from my home for the support of my household and family seventy quintals of flour and hardtack, which has been consumed and used up because of the long delay. When this food gave out, which must have been four months ago, the governor furnished provisions without ever failing. This declaration of what is here stated is faithful and true. Alonso Sánchez.

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, Alonso Sánchez, contador, made the preceding report and swore to it in due form. The commissary general accepted it. Alonso Sánchez. Jaime Fernández.

I, Captain Marcos Farfán de los Godos, state that I was one of the first to enroll under the royal banner to serve his majesty in this expedition to New Mexico under the command of Gov-

ernor Don Juan de Oñate. At the time that I left the province of Michoacán, I brought thirty equipped men and eighty horses of my own, without including more than two hundred brought by the people in my company. Because of the delay of the expedition, my people scattered to various places and localities, and most of the goods that I had brought were stolen, consumed, or lost. Without prejudice to my rights, I wish to declare before your grace what little I have left. This I do in compliance with the decree proclaimed by order of your grace. I shall not list clothing or finery, but only war equipment, as follows:

First, complete armor of cuisse, beaver, helmet, strong buckskin jacket, one harquebus and all its accessories with nothing missing, one sword, one dagger, and one halberd;

Some buckskin horse armor, lined with rawhide, for the flank, breast, head, and neck;

Two saddles, one *jineta*, the other *estradiota*, both with caparisons, stirrups, and all accessories;

Sixteen horses, six of them for fighting and the other ten for service; they bear different brands and marks and have been branded with my brand, which is shown in the margin;

Also, one saddle mule;

One tent of frieze made of sixty yards of sackcloth—I mean to say that the tent is made of frieze;

Further, for two soldiers, my servants, I have coats of mail, beavers, and cuisses;

The servants are Pedro de Rivas and Hernando Rascón.

I swear by God and this cross that this report is faithful and true. Marcos Farfán de los Godos.

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, Captain Marcos Farfán de los Godos made the preceding declaration and swore to it in due form. The commissary general accepted it and affixed his rubric. Marcos Farfán de Los Godos. Jaime Fernández, notary.

I, Captain Don Luis de Velasco, treasurer of the public treasury in the provinces of New Mexico, state that, in keeping with a decree published by command of your grace ordering all those who are going to serve his majesty in the provinces of New Mexico to make a declaration before your grace of the arms and

war equipment that each one is bringing, therefore, disregarding many things such as clothes for the adornment of myself and my wife, Doña Isabel, linen, and many other things that have been used up and pilfered by the soldiers and of which I have made a detailed report, all due to the delay of the expedition, I declare and manifest the following things:

First, one strong cart, with awning, well equipped, and oxen to pull it;

Ten horses for cavalry and service, branded with my brand, which is shown in the margin;

One wheel-lock harquebus, with powder flasks, molds, bullet screws, and all other accessories;

One coat of mail; one sword and gilded dagger;

One helmet and beaver;

Some cuisses of mail:

Some horse armor:

Two saddles, one jineta, the other for bridle;

Three bridles and three pairs of spurs.

This memorandum is faithful and true. Don Luis DE VELASCO.

In the valley of San Bartolomé, Santa Bárbara, December 7, 1597, Captain Don Luis Gasco de Velasco presented the above report and swore to it in due form before the commissary general. He swore that he had nothing else to declare, and the commissary general accepted his statement and affixed his rubric. Don Luis de Velasco. Jaime Fernández.

I, Captain Gerónimo Márquez, state that I am going to serve his majesty in the expedition to New Mexico, taking with me five children, male and female. Because of the great hardships that we have endured in the delay of the expedition, most of the goods that I had brought have been consumed, lost, or pilfered. What I have to report at present, in compliance with your grace's decree, is as follows:

One strong cart, with a bell and twelve oxen;

Thirty tame cows;

Thirty-five horses, of various brands;

One coat of mail, beaver, and cuisses;

I, Captain Alonso Gómez Montesinos, in compliance with the decree published by command of your grace, manifest here what remains to me from the long and laborious pilgrimage of this arduous expedition. Without reference to clothing, linens, and other things, I declare the following:

My personal armor consisting of coat of mail, cuisse, and beaver;

One harquebus, with accessories;

One crimson banner of damask with a picture of Christ in the center, the images of our Lady and Saint John on the sides, and on the back a picture of Saint James, the whole thing embroidered in gold;

Two bridles; and one large copper kettle.

I swear by God and this cross that everything listed in this declaration is faithful and true. Alonso Gómez Montesinos.

He did not sign because he did not know how. The commissary general accepted the report. Jaime Fernández.

Andrés Pérez: Statement of what Andrés Pérez is taking to serve his majesty on this expedition to New Mexico, presented by order of the inspector general, Juan de Frías Salazar:

First, two wheel-lock harquebuses equipped with powder flasks;

Two cuisses of mail;

Two helmets with beavers;

One leather jacket, one halberd, and one hocking blade;

Two sets of horse armor;

One dozen pairs of horseshoes, with nails;

Three dozen pairs of horseshoes, with nails;

One broadsword; two foils;

Two hooked blades and one iron halberd;

16. Both the carro and the carreta were two-wheeled vehicles, drawn by oxen or mules, with framework somewhat longer than wide. It is difficult to be sure how much difference there was between the two types of vehicles in Oñate's time, but the carreta may have been enclosed on the sides. Apparently, also, the carreta had wooden rims, but we are not certain that the carro was constructed any better, in view of the fact that in the documents it is sometimes stated specifically that a cart had iron rims. Martín Carrasco: I, Martín Carrasco, resident of this valley, state that I enlisted as a soldier in this New Mexico expedition more than a year and a half ago, and that, because of the long delay, my mules, horses, and the materials with which I planned to serve his majesty have been used up. In view of this difficulty, I sought to be released of my word to the governor, Don Juan de Oñate, and to return to Mexico. He considered my demand just, but made an agreement with me to furnish the necessary equipment for myself and a servant. For this reason, I remained. If he fulfills the agreement, I shall be obligated to remain, but if he defaults, I shall be free and exempted from going. In compliance with the decree proclaimed by order of your grace, I record and manifest the following:

First, myself with my sword;

One coat of mail, cuisse, and helmet with beaver;

One harquebus, fully equipped;

Eight horses;

One dozen pairs of horseshoes, with nails;

One chain, with collars:

Two iron bars:

Two picks; two wedges;

Five iron axes;

One copper casque;

Two quintals of iron;

One copper comal and one pail;

Fifty goats.

All of the above I present before your grace as my own and swear by God and this cross that this is true. I beg and entreat you in all justice to accept it as reported. Martín Carrasco.

So I come before your grace and declare the following:

Twelve horses and two jackasses;

CRISTÓBAL PÉREZ: I, Cristóbal Pérez, come before your grace and state that I do not have anything to manifest for the expedition to New Mexico, but that Governor Don Juan de Oñate has offered me everything that I will need for the trip, and I swear by God and this cross that this is the truth. Signed, CRISTÓBAL PÉREZ.

In the mines of Todos Santos, January 4, 1598, Cristóbal Pérez made the above declaration and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández, notary.

JUAN DE MEDINA: I, Juan de Medina, come before your grace to say that as I have nothing to manifest, I come only in person, and I swear by God and this cross that this is the truth. Since I do not know how to write, I asked Rodrigo Belmán to sign for me as witness. Rodrigo Belmán.

In the mines of Todos Santos, January 4, 1598, Juan de Frías Salazar, commissary general, accepted the above report of Juan de Medina and added his rubric. Jaime Fernández.

JUAN XIMÉNEZ: I, Juan Ximénez, come before your grace to say that Governor Don Juan de Oñate offered me everything necessary to make the trip to New Mexico, including arms, horses, and other things, at his expense, and so I am not manifesting anything except myself. I swear by God and this cross that this is the truth. Signed, JUAN XIMÉNEZ.

In the mines of Todos Santos, January 4, 1598, Juan Ximénez presented the above report before the commissary general and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

DIEGO HERNÁNDEZ: I, Diego Hernández, come before your grace to say that I have nothing to manifest other than myself, and I swear by God and this cross that this is the truth. Since I do not know how to write, I asked Rodrigo Belmán to sign for me as witness. Rodrigo Belmán.

In the mines of Todos Santos, January 4, 1598, Diego Hernández presented the above report and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

ALVARO DE BARRIOS: I, Alvaro de Barrios, appear before your grace and say that I come with the arms and at the cost of the governor, who offered to give them to me, and therefore I have nothing to manifest. I swear by God and this cross that this is the truth. Signed, Alvaro DE BARRIOS.

In the mines of Todos Santos, January 4, 1598, Alvaro de Barrios presented the above report before the commissary general, Juan de Frías Salazar, and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

DIEGO DE MEDINA: I, Diego de Medina, come before your grace and say that I have no arms or other things to declare, except myself, and as this is the truth, I so affirm and swear by God and this cross. Since I do not know how to write, I asked Rodrigo Belmán to sign for me as witness. Rodrigo Belmán.

In Todos Santos, January 4, 1598, Diego Medina presented the above report before Juan de Frías Salazar, commissary general, and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

DIEGO DE LANDÍN: I, Diego de Landín, come before your grace and declare a horse and a harnessed mule carrying my belongings, and an harquebus. I swear by God and the cross that all of this is mine and that there is no fraud against the king our lord. Signed, DIEGO LANDÍN.

In the mines of Todos Santos, January 4, 1598, Diego Landín made the above declaration before the commissary general and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

BARTOLOMÉ DE HERRERA: I, Bartolomé de Herrera, soldier in the New Mexico expedition, in compliance with the proclamation of your grace that each one must manifest the arms and other things that he is taking along, state that I have nothing to manifest because the governor, my lord, is giving me the arms, horse, and everything else. Signed, Bartolomé de Herrera.

In the mines of Todos Santos, January 6, 1598, Bartolomé de Herrera made the above report and swore to it in due form. The commissary general accepted it and added his rubric. JAIME FERNÁNDEZ.

JORGE DE SUMAYA: I, Jorge de Sumaya, in compliance with the proclamation of your grace to manifest the arms and other things for the expedition, say that I have nothing to declare because the governor, my lord, is giving me everything. JORGE DE SUMAYA.

In the mines of Todos Santos, January 6, 1598, Jorge de Sumaya made the above report and swore to it in due form. The commissary general accepted it and added his rubric. JAIME FERNÁNDEZ.

Juan Guerra: I, Juan Guerra, soldier in the expedition to New Mexico, say that, in compliance with the proclamation of your grace to declare my arms, I have nothing to manifest because the governor, my lord, is giving me everything. Juan Guerra.

In the mines of Todos Santos, January 6, 1598, Juan Guerra made the above declaration and swore to it in due form before the commissary general, who accepted it and added his rubric. Jaime Fernández.

Antonio Conde de Herrera, soldier in the expedition to New Mexico, in compliance with the proclamation of your grace that each one must declare the arms and other things that he is bringing, say that I have nothing to declare because Governor Don Juan de Oñate, my lord, is giving me the arms, horses, and everything else that is necessary. This is the truth. Signed, Antonio Conde de Herrera.

In the mines of Todos Santos, January 6, 1598, Antonio Conde made the above declaration and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

FRANCISCO DE VILLALBA: I, Francisco de Villalba, soldier in the expedition to New Mexico, in compliance with your grace's proclamation that each one must declare his arms and other things, say that I have nothing to manifest, because the governor, my lord, is giving me the arms, horses, and other things of that kind. Signed, Francisco DE VILLALBA.

In the mines of Todos Santos, January 6, 1598, Francisco de Villalba made the above declaration and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

CRISTÓBAL GUILLÉN DE QUESADA: I, Cristóbal Guillén de Quesada, soldier in the expedition to New Mexico, in compliance with your grace's proclamation that each one must declare the arms and other equipment that he is bringing, say that I have nothing to declare because the governor, my lord, is giving me the arms, horses, and other things. Signed, CRISTÓBAL GUILLÉN DE QUESADA.

In the mines of Todos Santos, January 6, 1598, Cristóbal Guillén made the above declaration before the commissary general and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

DIEGO DE CASTILLA: I, Diego de Castilla, soldier in the expedition to New Mexico, say, in compliance with your grace's proclamation that each one must declare his arms and other equipment, that I have nothing to manifest, because the governor, my lord, is giving me everything that I need. DIEGO DE CASTILLA.

In Todos Santos, January 6, 1598, Diego de Castilla made the above declaration before the commissary general and swore to it in due form. The commissary general accepted it and added his rubric. Jaime Fernández.

THE MUSTER ROLL ORDERED

At the corral and estate of Juan Díaz, resident of Todos Santos, January 7, 1598, Juan de Frías Salazar, his majesty's inspector and commissary general of the expedition to New Mexico and his lieutenant captain general, ordered Captain Luis Guerrero

and me, Jaime Fernández, notary, to notify the governor, Don Juan de Oñate, that on the following day, Thursday, January 8, he must send to the mines of Todos Santos, a league distant from the camp, all of his captains and soldiers with their arms in order to review and list them there, as this was an appropriate place for doing so in the manner most befitting his majesty's service. Furthermore, he was to order all of the captains, officials, and soldiers who reported their coats of mail and harquebuses to the commissary general to bring them, in order to manifest them in the presence of his grace. All of the aforesaid was to be executed without any evasion or delay whatsoever, in recognition of the importance of the royal service. Signed, Juan de Frías Salazar. I so testify, Jaime Fernández, royal notary.

At the river of San Gerónimo where the army on its way to the discovery of the provinces of New Mexico is at present encamped, January 7, 1598, I, the royal notary and secretary of this inspection, notified the governor, Don Juan de Oñate, in person of the preceding order. Upon hearing it he said that he would do what he was ordered, but he requested the commissary general, for greater clearness, to grant him the favor of first inspecting the arms of the expedition, both those of the governor and of the men, in order that he, as governor, might use the surplus to equip and help some poor soldiers. This was his reply and he signed it. The witnesses were Cristóbal Guillén and Cristóbal de Herrera; also present was Captain Luis Guerrero. Don Juan de Oñate. I so testify, Jaime Fernández, royal notary.

JUAN DE FRÍAS SALAZAR, royal inspector, . . . orders that no soldier shall bring a loaded harquebus for the review, under the most severe penalties, and in order that everyone may be informed of this decree, he orders that it be published. Moreover, he commands that no one except soldiers may enter the church where the inspection is to be held. JUAN DE FRÍAS SALAZAR. I so testify, JAIME FERNÁNDEZ, royal notary.

THE commissary orders likewise that no Indian, mulatto, or mestizo present himself at the review unless he clearly states that he is such, under penalty of death, so that, with this knowledge, that which best suits the service of his majesty may be done.

In order that everyone may be informed of this, Juan de Frías Salazar ordered this decree proclaimed. I so certify. Jaime Fer-NÁNDEZ, royal notary.

I certify that the two above decrees were published, to the sound of trumpet and crier, at the church in the mines of Todos Santos, among the captains, soldiers, and officials who were coming to enroll in this expedition and before many other persons who were present. Jaime Fernández, royal notary.

Juan de Frías Salazar... orders that no captain, soldier, official, or any other person whatever dare take part in the review or enroll in it for the sole purpose of passing it and then remaining behind and not going with the expedition. He ordered this under penalty of death on those who might violate the command, as persons defrauding the royal service, even though they should claim that they were remaining with the permission of the governor, or to do his bidding. Should there be anyone who through ignorance or persuasion had come to take part in the review with the above fraudulent purpose, he was to present himself before the commissary general and explain his case before enrolling for inspection, for by so doing the commissary would let him depart freely, without punishment, otherwise he would incur the aforesaid penalty.

In order that everyone may be warned, the commissary orders this decree to be published. Juan de Frías Salazar. I so certify, Jaime Fernández, royal notary.

I certify that this decree was proclaimed in the church at the mines of Todos Santos in the midst of the army and people of the New Mexico expedition and in the presence of the commissary general, the governor, the maese de campo, the sargento mayor, Captain Villagrán, and the other soldiers and officials who were coming to enroll. It was done by trumpet and crier on January 8, 1598. Jaime Fernández, royal notary.

Likewise on this same day, month, and year the above decree was brought to the attention of Captain Villagrá and his people who were present. Upon hearing it he replied that he understood, that he would not ignore it, but that his plan was to proceed with the expedition and not to turn back from the camp or remain behind or to attempt any fraud whatever. Such was his reply, and he signed his name. Gaspar de Villagrá.

JUAN DE FRÍAS SALAZAR . . . says that since it is evident that some people in the army have caused damages and offenses to the residents and ranchers of this province by slaughtering cattle from their ranches, and although he had tried to remedy the situation, he was told that they still continued to cause these damages, with the result that the people in this province, being few and poor, might abandon it, which would result in great loss to the service of his majesty; therefore, he decreed that no person whatever, irrespective of his position or rank, might kill or order the killing of any cattle, whether his own or those of another, anywhere in this whole province, except at the quarters where the army is lodged, under penalty of death. In order that a record might be kept of what was slaughtered at the army barracks, he ordered that one day in the week be set aside for this purpose and that the governor, Don Juan de Oñate, be required to select the day and to appoint someone at the camp to be present on that day to inspect the cattle slaughtered. The com-

missary appointed Juan Sánchez de Ulloa, resident of this province, to serve jointly with the governor's appointee, in order that the two together might examine the brands and marks of the cattle slaughtered and report to the commissary general. In order that everyone might be informed of this, he ordered that it be publicly proclaimed in the plaza de armas. He likewise summoned the governor to name the person and day. He signed it on January 4, 1598. Juan de Frías Salazar. I so certify, Jaime Fernández, royal notary.

At the quarters and encampment called the waters of San Gerónimo, in the kingdom of New Vizcaya, where his majesty's army which is going to New Mexico is lodged, a league more or less from the mines of Todos Santos, on Sunday, January 4, 1598, after a large number of these people had been assembled and in the presence of Governor Don Juan de Oñate and of many captains and soldiers, and in the presence of me, Juan Pérez de Donís, royal notary and secretary of the expedition, the above decree was proclaimed, word for word. Witnesses were Captains Gaspar López de Tavora, Juan Gutiérrez Bocanegra, Alférez Romero. I, the notary, certify that it was proclaimed by Juan, the governor's negro interpreter. Before me, Juan Pérez de Donís, notary.

On this same day, I informed Governor Don Juan de Oñate of the above proclamation, and after he had heard it he appointed Juan Pinero to attend to the matters in question, in coöperation with the person named by the inspector, and since the army had not had any meat this week, he designated tomorrow, Monday, as the day for slaughtering. For the following weeks, he designated Saturday as the day. So he decreed and signed. Don Juan de Oñate. Before me, Juan Pérez de Donís, notary.

DECREE

AT the mines of Todos Santos, January 28, 1598, Juan de Frías Salazar . . . said that since there were cattle belonging to others among those declared by Governor Don Juan de Oñate, as is shown by an affidavit of the inspection, he ordered that the cattle belonging to owners from this district be returned to them, and the cattle belonging to owners outside of this district be placed in the care of Pedro Sánchez de Fuensalida, resident of these

mines, in order that the owners might recover them or their value. He ordered further that the governor be summoned to comply with this proclamation, and he signed it. Juan de Frías Salazar. I so certify, Jaime Fernández, royal notary.

I certify that near the mines of Todos Santos, on January 29, 1598, as the army of the expedition to New Mexico was on its way, I notified Governor Don Juan de Oñate of the above decree. Upon hearing it, he answered that, whenever the said Pedro Sánchez wished, he could take out the said cattle from among his and that he should give an account of what was found. This was his answer, and I so certify. Witnesses, Francisco Romero, alguacil, and Jaime Fernández, royal notary.

DECREE

In the valley of San Gregorio, province of Santa Bárbara, December 21, 1597, Juan de Frías Salazar . . . stated that since he knew that Bartolomé Delgado, Pedro Sánchez de Chaves, and Pedro Sánchez de Fuensalida, residents of this valley and of Santa Bárbara, had ranches and corrals for livestock such as oxen, cows, calves, sheep, goats, mares, mules, and horses, and that since they had the greatest number and had perhaps given, loaned, or sold in confidence some of the said cattle to Don Juan de Oñate, . . . or to some other person on his account or in his name in order thus to be able to satisfy the detailed inspection and inventory, whereby great injury would result to the king's service and to the expedition, therefore, to prevent this he ordered the said Bartolomé Delgado, Pedro Sánchez de Chaves, and Pedro Sánchez de Fuensalida to declare under oath what cattle they had given, sold, or loaned to the governor, without concealing anything concerning this matter. He so decreed and signed. Juan de Frías Salazar. I so certify, Jaime Fernández, royal notary.

In the presence of Pedro Sánchez de Fuensalida, Pedro Sánchez de Chaves, and Bartolomé Delgado, and of the commissary general, I, the royal notary, notified them. They complied with what they were ordered and took oath in due form with the sign of the cross. Under oath they declared unanimously that they had not in any way given, loaned, or sold in confidence any cattle or animals to the said Don Juan de Oñate, or to anyone else

in his name, nor had such a matter ever been suggested to them, nor had anything been done in secret. The exception to this was that Pedro Sánchez de Chaves had, some twelve or thirteen days past, more or less, as he testified, sold to Antonio de Calahorra, resident of the mines of Ganacebí, 450 head of cattle at a peso and a peso and a half per head, according to their age, and that the money was still due him. Part of the sum was to be paid in the form of a negro slave, for which he had been given a bond. The said Antonio de Calahorra told this witness to take it to the governor, Don Juan de Oñate, but he does not know for what reason. This witness has delivered part of the cattle and at present he is to deliver 215 head, the remainder, to Don Juan de Oñate. He stated that the sale was bona fide, without any fraud; and that if any cattle with their brands should be found in Don Juan de Oñate's expedition, it was theirs and they would withdraw it, and he begged the commissary general to order such cattle delivered to them. This is what they declared, and they signed their names. Pedro Sánchez de Chaves. Bartolomé Delgado. Pedro Sánchez de Fuensalida. Jaime Fernández, notary.

DECREE

On the aforesaid day, month, and year the commissary general, after examining the testimony of Pedro Sánchez de Fuensalida, Pedro Sánchez de Chaves, and Bartolomé Delgado ordered that they proceed at once to sort out and remove their cattle, marked with their brands, from those of Governor Don Juan de Oñate and his army, and that they must not loan him any animals or carry on any improper dealings with him or with anyone else in his name, under penalty of losing double the number of cattle not taken away, to be paid to the royal treasury, and of incurring even more severe punishment. He so ordered and signed. Juan de Frías Salazar. I so certify, Jaime Fernández, notary.

The aforesaid Pedro Sánchez de Chaves, Pedro Sánchez de Fuensalida, and Bartolomé Delgado were notified of the above decree and they acknowledged it. I so certify, Jaime Fernández, notary.

At the mines of Todos Santos, December 25, 1597, Pedro de la Cruz, resident of the said mines, took oath in due form before the commissary general and declared that he had not given, sold, American Journeys—www.americanjourneys.org

or loaned any livestock, cattle, sheep, or other animals, to Don Juan de Oñate or any other person on his account. Thereupon the commissary general instructed him not to sell or loan anything to the governor in confidence in order to defraud the royal service, under penalty of losing twice the amount involved, and one thousand pesos, to be applied to the royal treasury. The said Pedro de la Cruz being present, I, the notary, informed him of the order and he acknowledged it. Signed by the commissary general, Juan de Frías Salazar. I so certify, Jaime Fernández, royal notary.

DECREE

By Order of Juan de Frías Salazar . . . it was decreed that no person, soldier, or official, or anyone else in the said army, irrespective of his rank, would be allowed to leave the camp now, on any account, either to return, go ahead, desert, or leave the barracks for any cause, except by express permission of the commissary general and by permission of no one else. They were ordered to comply with this decree under penalty of death. Under the same penalty, he ordered them not to take or slaughter the cattle belonging to anyone else or to take any other property, or to inflict any damage on Spaniard or Indian. In order that this decree might be known to all and that no one might pretend to be ignorant of it, he ordered that it be proclaimed publicly. Juan de Frías Salazar. I so certify, Jaime Fernández, royal notary.

At the San Gerónimo river, where the army that is going to New Mexico is at present encamped, December 21, 1597, I, royal notary, by order of the inspector and commissary general, certify that the above decree was proclaimed by trumpet and crier while most of the soldiers and officials of the camp were present. JAIME FERNÁNDEZ, royal notary.

DECREE

By Order of Juan de Frías Salazar . . . it was decreed that no soldier, captain, or official of those who had enlisted and passed in review would be allowed to turn back or cross this Conchas river, with the exception of those who, by order of the governor, might go to meet the father commissary and the other friars who are coming with him. Those who may go on this trip must ap-

pear before the commissary general and show him their authority and their reason for going, in order that a record may be kept of their names. The others must not leave the royal standard but must follow it without deserting or turning back, under penalty of death, which penalty will be executed without any excuse or delay. He ordered that the governor be notified of this decree and summoned not to act contrary to it or to grant permission to anyone to leave other than those who are to go after the friars. Those returning for the latter must have a written order, signed by the governor, in order that we may know who they are, for this befits the service of his majesty. Juan de Frías Salazar. I so certify, Jaime Fernández, royal notary.

Across the Conchas river, where the army that is going to the discovery of New Mexico is now encamped, on February 2, 1598, in the plaza de armas of the said camp, the above decree was proclaimed, and I likewise notified Governor Don Juan de Oñate, who listened to it. Witnesses were Captain Juan de Gordejuela Ybarguen and Gabriel Pertierra, alguacil, and others. I so certify, Jame Fernández, royal notary.

DISPUTE OVER THE GRETA

At the San Gerónimo river, a league from the mines of Todos Santos, in the province of Santa Bárbara, where the New Mexico expedition is encamped and of which Don Juan de Oñate is governor, on February 6, 1598, Don Juan de Frías Salazar . . . said that he had been informed that, in the inspection and inventory which Don Juan de Oñate had undergone at the said river, he had declared a quantity of greta¹⁷ as a substitute for something he lacked, and that, after it had been accepted in the inspection and review as part of the supplies for New Mexico, he had not taken it, but had sold it to a certain Pedro de la Cruz, resident of the said mines, who had transferred it to Juan Sánchez Barrena and he had concealed and buried it at that place. The commissary had been informed, also, that it was now being unearthed by some of Pedro de la Cruz's Indians and being loaded on a cart to be taken away. When the commissary asked the said Indians in the Mexican language whom the greta

belonged to and where they were taking it, they replied that they were taking it to the house of Juan Sánchez Barrena and that Governor Don Juan de Oñate had given it to Pedro de la Cruz. The commissary general ordered me to draw up this report in legal form and to certify it; and he signed it. Juan de Frías Salazar. I so certify, Jaime Fernández, royal notary.

In compliance with the preceding decree, I, Jaime Fernández, royal notary and secretary of the inspection recently held of the army of Don Juan de Oñate, governor and captain general of the provinces of New Mexico and of the army that is going to discover them for the king our lord, certify, on the basis of faithful testimony, that when traveling in the company of Juan de Frías Salazar, inspector and commissary general, and other persons, on our return to the city of Mexico, we found two Indians near the San Gerónimo river, where the inspection and inventory of Don Juan de Oñate were held, with a cart and oxen digging and picking in the dirt and mud, in which it seems a certain amount of metal, said to be greta, was buried, according to a sample that Governor Don Juan de Oñate had declared at this place. The Indians were trying to unearth and load it on their cart. The commissary general spoke to the Indians in the Mexican language and they replied, he said, that Governor Don Juan de Oñate had sold it to Pedro de la Cruz and they were gathering it by his order and taking it to the house of Juan Sánchez Barrena, resident of the mines at Todos Santos.

This is what transpired, the real truth, and nothing else. Witnesses, Captain Luis Guerrero, Francisco Romero, Gabriel Pertierra, Alonso Núñez Maldonado, and many others who accompanied the said gentleman. Jaime Fernández, royal notary.

This copy was made from the original, with which it was compared and corrected by order of his lordship, the Count of Monterrey, viceroy of New Spain, by virtue of the decree inserted at the beginning of this document. Mexico, May 30, 1602. Witnesses, Luis Ortiz de Vargas, Gerónimo Burgase, and Francisco de Ybarra, residents of Mexico. In testimony of the truth I affixed my sign. Juan de Aro, royal notary.

We, the undersigned notaries, attest and certify that Juan de Aro, who signed and affixed his seal to this copy, is a royal notary and that all of the documents executed before him are abso-American Journeys—www.americanjourneys.org lutely true and acceptable.
